Regional officials gathered on August 22, 2016 at the Hillsboro Municipal Airport to hear about the status of the first-in-the-world test of agricultural data collection using a large-scaled Unmanned Aerial System.

Elbit Systems of America and North Dakota State University are partnering to use a Research ND grant of \$350,000 to study agricultural uses for these unmanned aerial systems.

Elbit manufactures the Hermes 450 UAS, which is being used in the project. The flights are expected to be at varying heights up to 8,000 feet and using manned chase planes to follow the Federal Aviation Administration's guidelines which do not yet allow UAS to fly beyond the line of sight. Sen. John Hoeven (ND) and Rep. Collin Peterson (MN) were both in attendance to share their thoughts on what these advances in technology mean to the Red River Valley region and beyond. Elbit, an Israeli company, has much experience in unmanned aerial uses - primarily in defense and commercial aviation. Elbit president and CEO, Raanan Horowitz, is looking forward to additional research, which he thinks will be valuable to farmers.

allowing them to use the technology to make precise decisions for their crops.

Sarah Lovas, a Hillsboro farmer and crop constultant with Lovas Consulting and John Nowatzki, an NDSU Extension Service agriultural machine systems specialist, have been leading the project to assist with the future application of data. Beyond the agricultural application, Elbit is working with the University of North Dakota and Xcel Energy on a project to evaluate power lines.

This is a project of the Northern Plains Test Site in conjunction with Grand Forks EDC.

Degelman Industries, Ltd, a Regina, Saskatchewan, Canada company, built and opened a new distribution center in Hillsboro.

Degelman Industries, USA, was open and ready for business on March 1, 2016. The facility is a fully stocked Degelman whole-goods, parts, sales and service center focused on providing Degelman

equipment solutions for their USA customers.

Degelman products are shipped to this location - prepared as requested by their dealers and then shipped accordingly. Their Hillsboro location has removed their customs and brokerage concerns, making shipments to their USA customers more efficient. Company officials shared their reasons for locating in Hillsboro including the location on Interstate 29 which provides ease of access for their partner shipping companies and a family friendly community for their employees amongst other things.

Job Creation & Investment Dollar General Breaks Ground in Hillsboro & Mayville

Dollar General officials announced the development of two Dollar General stores in Traill County in 2016. Dollar General is a discount store providing name-brand products including food, snacks, health and beauty, cleaning supplies, apparel, housewares and seasonal items.

Traill County EDC staff worked to assist the developer with acquiring the former Country Hearth restaurant lot in Hillsboro, and an undeveloped lot next to Shopko in Mayville.

Each store is expected to have 6-8 employees and open in the spring of 2017.

Little voices can once again be heard at Hillsboro's newest child care center. After a former center closed its doors, Traill

County EDC and Hillsboro EDC worked together to recruit a new provider to run another child care center in Hillsboro. Tot Spot Hillsboro opened on September 7, 2016, with 28 children enrolled.

Experience, expertise and technology are what Tot Spot promises Hillsboro, and what the EDC groups found most attractive about their experience. Their program incorporates daily technology updates from each classroom directly to parents via an app which includes meal, nap and other care updates, along with curriculum updates and photos.

Tot Spot also operates five child care centers in the Fargo-Moorhead area. The Hillsboro facility is licensed for up to 57 children and expects to employ 14-16 people.

Traill County EDC set out to make a splash in 2016, with marketing directed toward spending more dollars locally. The campaign, Shop Local Traill, had two primary goals the first was to remind those living in the area to spend more of their money locally during the holiday shopping season. The second goal, was to inform the public on what the dollars spent locally mean to our local economy. Traill County EDC staff developed the ads which ran in local newspapers, radio and on social media.

The program also allowed Traill County EDC staff the opportunity to deliver over 125 packets of materials to local businesses. Businesses were given the option to contribute to the campaign, which in turn, gave them additional publicity on the marketing materials, gave them promotional items for their employees and customers and provided educational materials as well.

It was a great time to remind our businesses that shoppers do not have to support our local businesses, but rather, should want to becaues of the great service and other ways they may stand out. Overall, we felt the campaign was successful. Additional data collection will be done in 2017 prior to renewing a similar campaign.
